### Consent Form for Local Area Visits / Photographic Permissions

#### Year 4

Dear Parents and Carers,

Throughout the year, the school organises a number of routine visits and journeys away from the school site as part of the children's learning experiences. Such visits take place during the school day and tend to be local to the school area. We always ensure that adult to child ratios are appropriate and plan carefully so that the children are safely supervised.

Visits and journeys during the school day provide experiences for learning and present no significant risk to the health and safety of the pupils. All visits and journeys away from the school site are approved by the Headteacher.

The purpose of this consent form is for you as parents/carers to give your permission for your child to participate in any local, curriculum-focused visits and journeys away from the school during the school day. This consent will allow your child to leave the school site for a local visit on several occasions without having to sign a separate consent form for each visit.

Examples of such visits are:

- Visits to the local park, churches, libraries, shops, schools and other local outdoor sites.
- Town/village walks and the immediate countryside
- A brief coach trip to a familiar local site, i.e. Barnsley Metrodome or similar location for music festivals, curriculum based learning, etc

Consent requested here is only for local visits. Any visit that involves adventure activities (for example, climbing or water sports), or is a school led visit to a site with specific environmental hazards (for example, rivers or coastal fieldwork), or is at a distance beyond which immediate school help is possible, will require specific Informed Consent from parents/carers. In the case that we require additional consent, a further form will be sent to you for completion along with a letter detailing the visit e.g. Crucial Crew, Eureka etc.

#### **Additional Medical Information**

Please ensure that medical or other personal information currently provided by you and held by the school, with respect to your son/daughter, is kept up to date.

#### **Photograph Consent form for use by schools**

In school we take photographs of the children and we use these images on our school website and class dojo pages. We also use these as part of our school displays and sometimes in other printed publications e.g. our school prospectus.

### **Conditions of use**

- This form is valid indefinitely from the date you sign it.
- We will not re-use any photographs or recordings a year after your child leaves this school. Historic photographs will remain on our school website and social media feeds.
- We will not use the personal details or full names (which means first name and surname) of any child or adult in a photographic image or video, on our website, class Dojo or in our school prospectus or in any of our other printed publications.
- If we use photographs of individual pupils, we will not use the full name of that child in the accompanying text or photo caption.
- We may use group or class photographs or footage with very general labels, such as 'a science lesson', 'non-uniform day' or 'making Christmas decorations'.
- We will only use images of pupils who are suitably dressed, to reduce the risk of such images being used inappropriately.

To comply with the Data Protection Act 1988, we need your permission before we can photograph or make any recordings of your child. Please answer the questions on the forms link below to notify us of your permission.
